
Member Spotlight—Faye Swinehart

Faye was born in 1950 in Ozark, AL. She was raised in Elamville, AL, attended Barbour County High School, and graduated in 1968. She attended Wallace Community College during the period 1968-1970. She met her future husband, Jack Swinehart, in 1970. Jack had been drafted in 1966 and was, at that time, a helicopter pilot who had trained at Fort Rucker, and had served in Viet-Nam as a pilot during 1969-1970. He was wounded during combat earning a purple heart. They were married at the Chapel of the Flags at Fort Rucker in 1972.

During his military service Jack earned an undergraduate degree and an MBA from Auburn. While on active duty, Faye and Jack lived in Auburn, Fort Benning, Fort Rucker, Germany, and Fort Knox. Jack also served in Korea while Faye remained in Ozark. Jack retired in 1986 as a Major after 20 years of active service and both moved to Fort Worth, TX where Jack worked for Bell Helicopter. They returned to Ozark in 2001 where Faye currently lives. After 43 years of marriage, Jack died in 2015. (He still had shrapnel in his face when he died.) They have two sons: now 48 and 44 and one granddaughter. Both sons are also graduates of Auburn. The oldest son lives in New Mexico and serves as a civilian fight instructor after serving in the Air Force and retiring as a Major. Her youngest son teaches English at various locations around the world and currently resides in Ozark.

Faye attends the Trinity Methodist Church in Ozark and is involved with various activities within the church. In addition, she has faithfully served on our Board of Directors as our Surviving Spouse Affairs Officer for several years.

Legislative Report by Ray Collins

A bipartisan bill is being released in the Senate by Senator Rubio Florida and Senator Ossoff Georgia. The bill is called the Relocation Assistance for Military Families Act. The bill would require an in-depth review of relocation requirements and the assistance available to provide these requirements and the assistance available to meet these issues.

We spend a considerable amount of time each year talking about the failures of various entities in preparing, promoting, and implementing the Federal Budget. This year has every sign that this will be the 27th year our country has entered the new year without a completed budget process.

Some of the fallout from failure to complete the budget process including the following.

WASTED TAX DOLLARS. For instance, the continued resolution for 2019 cost DOD 19 billion dollars.

POOR EXAMPLE. The members of the military for example are required to care for their equipment, their bodies and any entity of value to the best of their ability.

EROSION OF TRUST How do we form a sincere trust in an entity that can't figure a cost to operate and implement strategies to accomplish that operation.

SIMPLE SCHEDULING. Congress always finds a way to go into recess for the month of August. Is it unreasonable to expect Congress to abide by their entire schedule which includes passing a full budget before October One each year. It isn't t like they are caught off guard.

An heir who inherits a Roth doesn't inherit a tax bill. Those who inherit large accounts that can no longer be distributed over a lifetime particularly could benefit from inheriting tax-free Roth accounts...."

WORDS MATTER—I recently taught a Sunday School Class lesson that discussed the fact that words matter to God. He keeps a record of our words. Jesus said, "I tell you that on the day of judgment people will have to account for every careless word they speak" (Matthew 12:36). I told the story about a black farmer who grew excellent quality corn. Every year he won the award for the best grown corn. One year a newspaper reporter interviewed him and learned something interesting about how he grew it. The reporter discovered that the farmer shared his seed corn with his neighbors. "How can you afford to share your best seed corn with your neighbors when they are entering corn in competition with yours each year?" the reporter asked. The farmer said, "Why sir, didn't you know? The wind picks up pollen from the ripening corn and swirls it from field to field. If my neighbors grow inferior corn, cross-pollination will steadily degrade the quality of my corn. If I am to grow good corn, I must help my neighbors grow good corn."

So, it is with our lives. Those who want to live meaningfully and well must help enrich the lives of others, for the value of a life is measured by the lives it touches. And those who choose to be happy must help others find happiness, for the welfare of each is bound up with the welfare of all. And so, it is with our words. They travel - - - on the wind - - - like pollen - - - like a virus. They can either build up those around us by our words of encouragement, support, uplifting, promotion, and praise. Those around us can then build up those around them. Or, we can use words that humiliate, tear down, criticize, hurt, and destroy those around us. If we do the former, judgment day might be a little easier for us. If it's the latter, we will be a cancer on the very fabric of our society.


